Tournament Entry and Payment:

The entry fee is **\$300.00** per one-day or two-day tournament. A half payment of \$150.00 per tournament entered will secure entry in the tournament(s). Full payment will secure the team starting position in the order they are received. ***NEW*** The half-payment option is available until May 1st, 2008 and balances must be paid in full by this date. All entries received after May 1st, 2008 must be paid **in full** at time of entry. All one-day tournaments are open to 75 teams. All two day tournaments are open to 150 teams. Full payout for one-day tournaments is based on a field of 60 teams.

Refund Policy:

Cancellations made more than 60 days prior to tournament will be refunded in full. Cancellations less than 60 days prior to tournament will be refunded in full only if your team can be replaced. If your team cannot be replaced and the tournament has a full field, no refund will be given. Emergencies will be given special consideration.
